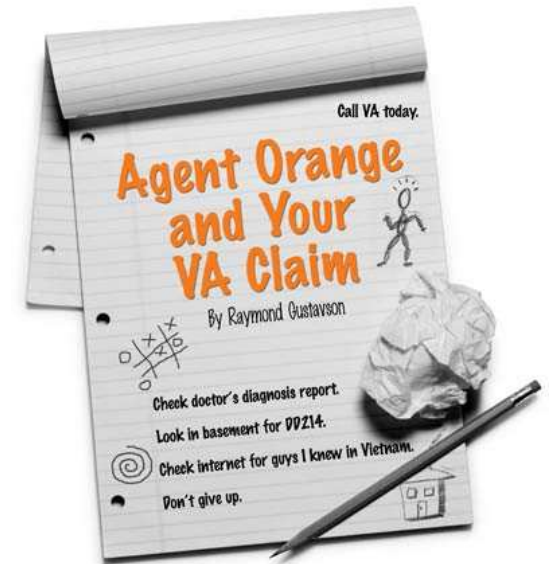

**WHAT IS “PRESUMPTIVE”
SERVICE CONNECTION?**

VA presumes that specific disabilities diagnosed in certain veterans were caused by their military service. VA does this because of the unique circumstances of their military service. One of these conditions is diagnosed in veterans in one of these groups, VA presumes that the circumstances of his/her service caused the condition and disability compensation can be awarded to the veteran.

**WHAT CONDITIONS ARE
“PRESUMED” TO BE CAUSED BY
MILITARY SERVICE?**

Vietnam Veterans and Navy Personnel that served in the water offshore of Vietnam!

EXPOSED TO AGENT ORANGE!

Served between January 9, 1962 to
May 7, 1975

**YOU MAY BE ELIGIBLE FOR VA
SERVICE CONNECTED DISABILITY
IF YOU HAVE ONE OF THESE
LISTED CONDITIONS.**

**PRESUMPTIVE CONDITIONS ASSOCI-
ATED WITH EXPOSURE TO
AGENT ORANGE!**

- Chloracne or other acne form diseases similar to chloracne
- *Porphyris cutanea tarda*
- *Sot-tissue sarcoma (other then osteosacoma, chondrosacoma, kaprosl’s sarcoma or mesothelioma)*
- *Hodgkin’s Disease*
- *Multiple Myeloma*
- *Respiratory Cancers (Lung - Bronchus - Larynx - Trachea)*
- *Non– Hodgkin’s Lymphoma*
- *Acute and subacute periphera neuropathy**
- *Type II Diabetes (Secondary Issue Also need to be included in this claim)*
- *Chronic Lymphocytic Leukemia*
- *Hypertension - Soon to be Added*

ONE OF THESE LISTED
CONDITIONS**

WHAT WILL I NEED?

Copy of Your DD-214

Copy of Marriage License (if married)

Copy of Divorce Papers if you have been divorced and remarried (need them all if you have been divorced more in once)

Social Security Numbers for Your Dependents and spouse

Doctor’s Name’s, Address, Phone Numbers

Current Records Showing your Current Diagnosed Condition or conditions

This process will take about an hour to complete.
